

# THE TRUST COVENANT

## Consensual Power Exchange Agreement

This Trust Covenant Agreement (“Agreement”) is entered into on the date of execution by and between the undersigned participants through **TheTrustCovenant** platform.

For the purposes of this Agreement:

- **“Dominant”** refers to the consenting participant assuming a guiding or authoritative role.
  - **“Submissive”** refers to the consenting participant voluntarily offering service, obedience, or power within defined limits.
  - **“Platform”** refers to *TheTrustCovenant*, which facilitates this Agreement but is not a party to it.

### 1. Purpose of Agreement

This Agreement exists to formally document a **consensual power-exchange relationship** entered into voluntarily by both parties. It is intended to establish mutual expectations, boundaries, responsibilities, and safeguards in a respectful and ethical BDSM dynamic.

This Agreement is **not** a marriage, employment contract, or transfer of legal rights.

### 2. Voluntary Participation and Capacity

Each party affirms that:

- They are **18 years of age or older**
  - They enter this Agreement **freely and without coercion**
  - They are mentally capable of informed consent
  - They may withdraw consent at any time in accordance with this Agreement
- 

### 3. Scope of Services and Duties

#### (a) Submissive Role

The Submissive agrees to offer services, obedience, or participation in activities as **explicitly negotiated and mutually agreed upon** in advance.

Duties may include, but are not limited to:

- Acts of service
- Protocols or rituals
- Training, discipline, or structure
- Companionship or lifestyle submission

All duties must remain within the **agreed boundaries** and applicable law.

### **(b) Dominant Role**

The Dominant agrees to:

- Act responsibly and ethically
  - Prioritize the Submissive's physical and psychological safety
  - Respect all limits and safewords
  - Never intentionally cause serious harm or exploit vulnerability

## **4. Consent, Limits, and Safewords**

### **(a) Consent**

Consent is **ongoing, revocable, and conditional**. Prior consent does not imply future consent.

### **(b) Limits**

All hard and soft limits must be documented via the Platform tools and respected without exception.

### **(c) Safeword**

A safeword or signal must be established before any activity begins. Use of the safeword requires **immediate cessation** of the activity.

Failure to respect a safeword constitutes a material breach of this Agreement.

---

## **5. Discipline and Correction**

Any form of discipline:

- Must be **previously consented to**
- Must never occur while a safeword is active
- Must never involve humiliation, harm, or punishment beyond agreed parameters
- May not be used as retaliation or emotional control

Discipline is a **training mechanism**, not abuse.

---

## **6. Compensation and Expenses**

This Agreement's financial compensation will be **\$5,000** or **£3700** depending on your location.

When compensation, gifts, housing, or expense reimbursement are agreed upon:

- They must be clearly documented

- They do not create employment, dependency, or obligation
  - Either party may discontinue such support without penalty unless otherwise agreed
- 

## 7. Term and Termination

This Agreement:

- Begins on the date of execution
- Continues until terminated by either party

**Termination may occur:**

- Immediately upon written notice
- Immediately upon safeword termination
- Immediately upon breach of consent or safety

Termination carries **no penalties**, obligations, or continuing authority.

---

## 8. Independence and No Agency

Nothing in this Agreement:

- Creates an employer-employee relationship
- Creates legal agency, ownership, or guardianship
- Transfers decision-making authority outside the agreed scope

Each party remains an **independent individual**.

---

## 9. Content, Records, and Materials

Any media, logs, or records created during the relationship:

- Remain the property of the creator unless otherwise agreed
- May not be shared publicly without explicit consent
- Must comply with platform content rules

The Platform may retain records solely for moderation, safety, or legal compliance.

---

## 10. Platform Disclaimer

TheTrustCovenant:

- Is a facilitator, not a participant
- Does not verify real-world conduct

- Is not liable for actions taken outside the Platform
  - Reserves the right to suspend or terminate access for violations
- 

### 11. Breach

Violation of consent, safewords, age requirements, or safety obligations constitutes a **material breach** and may result in:

- Immediate termination
  - Platform ban
  - Reporting to relevant authorities if required by law
- 

### 12. Governing Law

This Agreement shall be governed by the laws of the jurisdiction specified in the Platform’s Terms of Service.

---

### 13. Acknowledgment

By signing electronically through TheTrustCovenant, both parties affirm that they:

- Have read and understood this Agreement
- Accept its terms voluntarily
- Enter into this Agreement in good faith
